3. Barriers to future attainment (for pupils eligible for PP, including high ability)	
In-school barriers (issues to be addressed in school, such as poor oral language skills)	
A	Attainment for Moorlands disadvantaged pupils was lower than the Trust averages for PPG pupils when the Term 1 baseline data was collected in October (except for Y1 reading).
B	English as an additional language (2) which can slow progress across subjects and hinder social and emotional development.
C	For a small group of children entitled to the PPG, poor behaviour including attachment difficulties impacts on their ability to build relationships with peers and staff; this inhibits learning progress.
D	Poor self-esteem and low engagement in learning, which can develop as a lack of emotional resilience, which prevents children from fully engaging in all learning opportunities.
E	We have identified that speech and language needs are disproportionately prevalent in the school this year among disadvantaged pupils (35% of disadvantaged pupils have SL needs compared to 8% of non-disadvantaged pupils)
External barriers (issues which require action outside school, such as low attendance rates)	
F	Aspirations held by pupils and their families can be low, which means encouragement to attend after school clubs and to participate in other life widening experiences offered by the school is needed.
G	Attendance is disproportionately low for pupils entitled to the PPG (Non-disadvantaged attendance 98.3%, disadvantaged attendance 94% in T1 2020)
